Director's Report

The 2019-2020 academic year has been fascinating. Between July and March 13, the Emeritus College experienced growth in membership activities and attendance at events, headed toward a record year of fundraising, met several milestones in our strategic plan, and developed new ideas for the College. As spring break started, the University and the country began to address the COVID-19 pandemic with a shutdown and shelter-in-place prevention strategy. It was obvious that the University would complete the spring semester virtually. The Emeritus College had to re-focus and re-design its approach to meeting the needs of our faculty. A guiding goal of the College is engagement. The College mission statement served as our guidepost: *Facilitate high quality engagement and involvement of Clemson University Emeriti Faculty in service to the University, the Community, and in collegial interactions among Emeriti Members.*

Over 15 weeks, the Emeritus College hosted 24 virtual events with 407 attendees. We found a way to stay engaged, to reach out to our members, to touch people when we could not meet in-person. While Zoom meetings are not the same as in-person, the technology has allowed us to "see" each other. As Michael Kohl, Librarian Emeritus, commented in a recent Zoom meeting, while Zoom does allow us to see people, it does not allow for personal "side" conversations that happen when we meet. We look forward to the University helping us to reopen our facilities and welcome people back into the College spaces wearing masks and social distancing. Safety and health are our primary goals, and we will continue to offer and expand our virtual programming to stay engaged with you. Our overall attendance at college in-person and virtual programs was 1094, an increase of 168.1%. Our overall attendance for the year at all social and program events was 1495 (36.8% increase).

I want to personally thank Executive Vice President and Provost Bob Jones and Vice President of Public Service and Agriculture George Askew for their support of the Emeritus College this academic year. Two major projects were made possible by their combined financial commitments. If you have not seen our new signage, drive by the Emeritus College building. It is no longer the "CAT" building. The College name appears on the sign, along with Regulatory Services, our landlord. The signs include directions to parking and walkway signs to help people find the entrance of the building. The second project was the upgrade to our large conference room. We received Provost Performance Credits and PSA contributions that allowed the upfitting of the conference room for videoconferencing. Our plan for 2020 was to initiate online delivery of our in-person seminars to reach our emeriti who do not live in the area or who are unable to travel. Little did we know that the pandemic would move all our programming to a virtual platform. The work has been completed and we look forward to streaming our programs in the future.

A special thank you to Dr. Don McKale who has served as the Chair of the Advisory Board and Executive Committee. Dr. McKale has worked tirelessly this year to ensure that the transitions to virtual programming has met our members' needs. The Advisory Board has accomplished numerous goals as outlined in the strategic plan. The College raised \$18,111 for scholarships, the Kenelly-Voss endowment, and the general fund, an increase of 54.6%. A list of our donors is included in the report.

A special thank you to Nicole Hanewald. Nicci keeps things moving. She has been working from home. Nicci has become our personal Zoom trainer. As you know, Nicci is the heart and soul of our college. As the only full time employee, she truly makes a difference.

I also want to thank CCIT for their leadership in placing Curt Russell in the Emeritus College. Whether you were able to work with Curt in the building (pre COVID-19) or remotely since, you know what a wonderful resource person Curt is and how he has helped the emeriti faculty.

This issue of *The Academy* includes the Annual Report. Thanks to Dr. Jerry Trapnell and his committee for the development of the Strategic Plan which guides our work. This has been a great year. A different year, but good, nonetheless. Nicci, Curt, and I look forward to 2020-2021 as we navigate the changes and manage our current pandemic. Wear your mask, social distance, wash your hands, and stay safe.

Annual Report and Executive Summary

- At the end of the 2019-2020 fiscal year, the Clemson University Emeritus College (EC) database has 854 members with active contacts, a decrease of 0.12%.
- Improved EC communications with printed publications and weekly emails on EC activities.
- The EC worked with six classes of business writing students during the fall and spring semesters to improve our communication strategies and our social media presence.
- A survey of emeriti faculty was conducted, and the results are provided in this report. In addition, the Office of Institutional Research provided updated information on our members and their current research and teaching activities both paid and unpaid.
- The College presented the following awards:
 - 1. Recipients of the Student Scholarship funded by emeriti faculty: Rayyan Alam, Drew Johnson, and Jordan Kiser.
 - The EC Advisory Board approved a new member recognition program, the I. Dwaine Eubanks Emeritus College Fellows program to recognize EC members for their unremunerated service to the Emeritus College or through initiatives sponsored or supported by the EC. The first fellows selected were announced on August 3, 2020 at a Virtual Celebration.
 - Emeritus Award for Community Service: During the 2019-20 fiscal year, EC presented its first Community

Service Award to a member for outstanding community service: Dr. Linda Gahan, Professor Emerita of Biological Sciences.

- Major EC events, with 1495 total participants, an increase of 36.78%; we were unable to host Emeritus Day in April.
 - 1. 2019 Fall Annual Meeting and Picnic: 200
 - 2. 2019 Annual Holiday Social: 201
 - 2019-2020 educational seminars, focusdiscussion luncheons and tours were held on social media, music events, library, technology, academic plans, faculty and student advocacy, 1094; a 168% increase over the previous year.
 - 4. 24 Zoom seminars, with 407 participants; making the connection using Zoom helped us stay engaged.
- EC faculty members donated \$18,111 to support two undergraduate annual student scholarships, the Kenelly-Voss Emeritus College Endowment, and the college's social events and programming. This is an increase of 54.6% from the previous year.
- Signage for the building was completed.
- Health and safety in the Emeritus College is a critical concern. This year we added chairs without rollers to prevent falls. The Director and others in the building were certified/ recertified in basic life support and first aid. The College hosted the Sullivan Center for a flu shot clinic for emeriti. As COVID-19 resulted in the closing of the facilities, the College expanded its programming using the Zoom platform.
- The seminar room renovations were planned to add cameras and microphones to facilitate webinars originating from the room to support continued social distancing and to involve our emeriti who are not located in the region.

Strategic Goal Achievements:

1. Increase visibility and recognition of the Emeritus College across the University and beyond:

- Consulted with Creative Services and two logos, visible in this report, have been made available for the Emeritus College consistent with the overall university revised brand guidelines. Transition to all EC communications and documents are in process.
- Website updated and made interactive, moving the calendar of events and improving the directory of emeritus faculty.
- *EC Happenings*: Weekly emails are transmitted to members regarding EC news and events. The emails have been redesigned to improve the content for faculty.
- *The Academy*: Newsletter designed highlighting EC events, news, etc. Several new designs are being considered for this upcoming year. The leasing of a new printer that will enable the college to print, bind and fold, will reduce the overall costs of newsletters.
- The improved signage on the outside of the

building have been completed and were made possible by our work with Regulatory Services and PSA which also are in the facility. The signage includes several signs for parking and walking along with the overall improved



visibility of the building with updated groundwork.

• The College has continued to reach out to the Clemson community and this year hosted seminars and meetings to improve our relationships and expand opportunities for emeriti faculty to participate in university activities:

2. Increase involvement and engagement of all Emeriti Faculty in activities of the College:

- Communications with Academic Deans and Department Chairs remains a work in progress to communicate to them their respective EC members.
- Communication efforts to all EC members includes weekly emails on EC events, creation of a new calendar, and annual report.
- Completed a survey of member interests.
- Institutional Research Office emeriti data analyzed.
- Addition of emeriti faculty to campus-wide emails (Our Clemson; President Letters).
- Plans for the addition of camera and microphones to enable web-based seminars was initiated prior to COVID-19 and the shelter-in-place orders.
- Implemented seminars using ZOOM in April, with continued programming and meetings held virtually.
- Reconfigured space in response to the COVID-19, including antimicrobial keyboard covers, plans for reducing inperson presentations and increasing webbased platform for synchronous seminars.
- Plans are being developed for Virtual Celebrations and discussions regarding

how and when the college will be able to host future social events.

3. Serve Clemson University:

- Expansion of EC members' involvement on University Councils/Committees/ Task Forces is a work in progress. EC is represented at the Faculty Senate on a regular basis.
- Worked with six Client-Based Writing Classes in 2019-20. The student groups prepared thorough recommendations related to improvements in our written communications and social media opportunities.
- EC faculty are actively involved in leading and supporting the CIS/CESP program for international students and faculty fall 2019: CESP 45 students, with 33 passing (70%) and 8 students and 1 faculty member participated in the CIS program; Steve Stevenson and Adolph Beyerlein continued student mentoring (8 total students) during the Spring semester using Zoom. The graders and mentors plan to use Zoom, if live interviews are not feasible in the Fall 2020.
- Student scholarships were presented this year to: RayyanAlam, Bioengineering major received the Kenelly-Voss Scholarship and Drew Johnson, Psychology, and Jordan Kiser, Political Science, received the Emeritus College Annual Scholarships for Excellence.
- Clemson faculty from across the university provided seminars for the emeritus faculty this year. We were honored by their participation and look forward to a continued relationship with them.
- EC faculty participated with HR in retirement briefings for Clemson faculty.
- The IR review of the emeritus faculty demonstrated that 76 emeriti faculty taught 104 classes in the Fall of 2019. Forty-seven (47) of the faculty did so with remuneration. In addition, 126 emeriti faculty were serving as chairs of thesis and dissertation

committees; another 12 were co-chair and another 515 were on student committees.

- Vic Shelburne served as co-chair and Provost Fellow of the Clemson University Commission on Sustainability.
- Sterling (Skip) Eisiminger is a volunteer instructor in the ESL program, Learning English Across Frontiers (LEAF) and used Zoom to be able to continue to work with his student groups throughout the Spring semester.

4. Serve the broader community:

- EC faculty continued to support numerous non-profit groups across the Clemson community, including, but not limited to OLLI, Sertoma, the Free Clinic, the Community Foundation of Greater Clemson, and others.
- The Advisory Board expanded the role and objectives of the Community Outreach Committee.

5. Facilitate substantive, quality social and educational program of events for Emeriti Faculty:

- Overall, 1495 emeriti faculty have attended one or more events during this academic year, an increase of 36.78%. At the same time, we were unable to host our largest event of the year, Emeritus Day.
- Major EC social events in 2019-20 included: Fall Picnic (200) and December Holiday Party (201).
- COVID-19 has limited our ability to have inperson events. Our last in-person seminar was March 13, 2020. Since that date, 24 programs and meetings have been held using the Zoom platform. We are excited to report that our attendance at events has been strong, with 407 participants.
- A record number of participants for our seminars, programs and meetings in 2019-20, with a total of 1094 or a 168% increase from the previous year.
- Our programming has included tours, seminars, luncheons, music events and

panels. Our speakers have included emeriti faculty, current Clemson faculty, guests from other universities, and Clemson students (current and recently graduated).

• EC faculty members donated \$18,111 to support two undergraduate annual student scholarships, the Kennelly-Voss Emeritus College Endowment, and the college's social events and programming. This is an increase of 54.6% from the previous year.

Emeritus College Survey Report

Between October 27 and November 9, 2019, the Emeritus College with an undergraduate Client-Based writing class conducted a survey of emeritus faculty to gather their opinions about the college, our communication strategies, and future needs of the members. In addition, we used the Office of Institutional Research to provide additional data about our entire membership. These are the results of the two data collection activities.

In summary, 85% of our members are white; 22% female; 48% between the ages of 67-78 and 33% between the ages of 78-86; and 91% live in South Carolina.

We also learned that in the fall semester, 76 emeriti taught 104 sections of classes for the university, 47 of whom were not remunerated for their role in the classroom. In addition, another 126 faculty chaired graduate students' thesis and dissertation committees. While 12 served as co-chair; and another 515 were on committees.

The college had 132 responses to the email distributed survey link (17.6% rate of return). The demographics of the survey respondents closely mirror our total population, with 74.6% male and 24.6% female. The good news is that 95% of the responses indicated that they were satisfied with their overall experience with the Emeritus College and with the way in which the college was communicating with them regarding programs and events. The frequency of the communications from the college to members were appropriate and the types of events and programs met member needs.

One key comment related to those faculty who do not live in the Upstate of SC. This was instrumental in the Executive Committee's plan to up-fit the conference room for synchronous distribution of seminars using web-based platforms to provide programming to members not able to join events in the building.

The client-based student classes had several recommendations for the College which included a new logo, active social media platforms (Facebook, Instagram, LinkedIn), student partnerships, and fundraising by selling products. Our members are not actively engaged in the social media platforms. Eight emerti had Instagram accounts and only 45% had Facebook accounts.

The classes did have some great ideas on our weekly newsletter to increase the readability, as well as a shared calendar. The Advisory Board and Executive Committee have discussed the student papers and recommendations. Several steps have been taken, including a redesign of the EC Happenings weekly newsletter as well as a shared calendar has been made available. In addition, in working with the Clemson's branding office, new logos for the college have been provided that are aligned with the University's current brand guidelines and colors.

We plan to continue to work with the Office of Institutional Research to review our faculty data on annual basis. Our next survey of our faculty will be conducted this fall to address interest in community outreach and a speaker's bureau.

Emeritus Award for Community Service



The Emeritus College was honored to bestow the Emeritus Award for Community Service to Dr. Linda Gahan, Associate Professor Emerita of Biological Sciences, at its Annual Meeting and Fall Picnic in October 2019. This award was established by the Emeritus College

Advisory Board to recognize emeritus faculty members who provide extraordinary service to the community or their professions outside the university and Emeritus College. This award is presented in odd-numbered years with the inaugural year being 2019.

For the past several years, Dr. Gahan has been involved with Concerned Citizens for Animals. A significant number of animals are abandoned at the end of a given spring semester, resulting in several abandoned cats throughout the Clemson community. Linda feeds 13 cats seven days a week between 6:30 and 7:30 am, as well as monitors their health and behavior around the area of the former Clemson House.

Dr. Gahan is a supporter and benefactor for Clemson Community Care and the Clemson Child Development Center. She is the past president of the Clemson League of Women Voters and has served in the presidential capacity four times. She not only served as an officer but also does several service activities within the League including three international women's workshops and training programs in Kenya. Her volunteer outreach can be seen in her other community service activities: Secretary, Clemson-Central Advisory Board, 2010-12; Past moderator at Fort Hill Presbyterian Women, 2011-12, 2017-19; Co-Coordinator of Family Promise at Fort Hill Presbyterian Church, 2014-20; Chaired a fundraiser for the local P.E.O. Sisterhood Chapter for women's college scholarships. In 2012, Linda received the Clemson Rotary Club Community Service Award. Congratulations to Dr. Gahan!

Clemson Leaders in the Association of Retirement Organizations in Higher Education (AROHE)

AROHE was founded in 2002 and grew from many years of informal conferences led by universities across the United States. AROHE's history details the leadership and influence of successful long-standing organizations including FSU, Clemson University, UCLA, University of Southern California, Indiana University and University of Washington.

The Emeritus College at Clemson founded in 2003 as the brainchild of Doris Helms and with the hard work of Jerry Reel, and the leadership of Diane Smathers, a concept paper was developed for a more formal structure for the College. It required space and a little money. An advisory board was named, emeriti took ownership of the College and provided direction, programming, and donations.

At the same time, the emeriti became more engaged in AROHE leadership as well. Diane produced an article for AROHE on Clemson's Emeritus College in 2008. In 2011, Lucy Rollin was elected to the board of AROHE. In 2013, Lucy Rollin was chair of the AROHE nominations committee. In 2015, Larry Gahan was elected to AROHE's board; followed by Lucy Eubanks who was elected secretary in 2017, and Hoke Hill who was elected to the AROHE board in 2019.

Lucy Eubanks continues to serve the Advisory Board of the Emeritus College as our liaison to AROHE and in that role submits regular articles on Clemson's activities, highlighting special events and activities of our college. In October 2018, the Clemson University Emeritus College was recognized by the AROHE with an Innovation Award for the Clemson English-Speaking Proficiency (CESP) testing and the Conversations with International Students (CIS) program.

A special thank you to our Clemson emeriti faculty who are leaders in AROHE activities and keep our college informed. It is essential that we remain engaged with other emeritus colleges and retired organizations and that we learn new or different ways to meet the needs of Clemson's emeriti members.




