I have completed my first six months as Director of the College and it has been a truly inspiring experience. You, the emeritus faculty, seek opportunities to be intellectually engaged and involved with each other and with the university. I am amazed at the new challenges and areas of interest that you have developed in the emeritus phase of your careers. Clemson emeritus faculty continue to pursue their research and scholarship and explore new disciplines.

My primary goal is to provide the emeritus faculty with a physical environment and a variety of educational and social programming where you can continue to grow and collaborate. If I am to be successful, the college must be a place where faculty meet for seminars, workshops, or open forums. A list of our upcoming events is included. We continue growing the number of faculty who come to the college each week for programs.

We expanded our programming to include musical events and small group informal discussion roundtables. We have taken down panels and redesigned space to accommodate faculty gatherings. The creative displays in the college are expanding as we move to add additional three-dimensionsal forms of creative works.

We are developing new opportunities for faculty to participate within the university as well. I feel like we have a team of interdisciplinary colleagues who have similar goals and are helping daily to energize the Clemson University Emeritus College.

Finally, we need to develop and expand our Foundation activities and develop sustainable endowments to support an Emeritus College Fellows program and an emeritus faculty travel and scholarship fund then we can continue our student scholarships and expand our programs and events.

The annual report has been designed around the college's strategic plan approved under Dr. Eubanks' and Dr. Trapnell's leadership. We are now collecting data so that we can track our progress overtime.

# 2018-2019 Executive Summary

- At the end of the 2018-19 fiscal year, the Clemson University Emeritus College (EC) database reflected 855 members with active contacts, an increase of 1.78%.
- In October 2018, the Clemson University Emeritus College was recognized by the Association of Retirement Organizations in Higher Education (AROHE) with one of its Innovation Awards for the Clemson English-Speaking Proficiency (CESP) testing and the Conversations with International Students (CIS) program. These programs focus on enhancing the English proficiency skills of international students, faculty, and staff. Under the leadership of Dr. Adolph Beyerlein, Professor Emeritus of Chemistry, 21 departments have benefitted from these programs. Since its inception in 2014, 273 international students have participated in the testing supported by 13 emeriti faculty serving as graders (75% of the students participating in the CIS program have passed the CESP oral exam). Some 32 emeriti faculty have served as CES mentors since 2014.
- The University and College mourned the sudden passing of EC Director, Dr. I. Dwaine Eubanks, Professor Emeritus of Chemistry. Emeritus College member, Dr. Dan Warner, stepped in to serve in an interim role and a new director, Dr. Debra Jackson, was appointed in January 2019, following an internal search.
- Improved EC communications with printed publications and weekly emails on EC activities. Because of the change in leadership, only three newsletters (*The Academy*) were

distributed in the academic year, but 52 weekly emails (*EC Happenings*) were sent to the members. In addition, follow up emails were sent to announce and remind members of upcoming events.

- The College presented the following awards:

  - 2. Emeritus Award for Research and Scholarship: **Dr. John Morse**

  - The EC Advisory Board approved a new member recognition program, the

  - 5. Emeritus Award for Community Service: During the 2019-20 fiscal year, the EC will present its first Community Service Award to a member for outstanding community service.
- Major EC events included, with **1093** total participants
  - 1. 2018 Fall Picnic: 220
  - 2. 2019 Annual Holiday Social: 195
  - 3. Spring 2019 Emeritus Day, 17 new emeriti faculty were recognized and welcomed to the College, with a total attendance of 270.
  - 4. Spring 2019, educational seminars, focusdiscussion luncheons and tours were held on social media, music events, library, technology, academic plans, faculty/ student advocacy: 408
- EC faculty members donated \$11,715 to

support two annual undergraduate student scholarships and EC social events and programming. This is a decrease of 41% from the previous year.

- Redesign of the Emeritus College space to promote collaborative exchange programming.
- Health and Safety in the Emeritus College is a critical concern and this semester we added chairs without rollers to prevent falls. In addition, the Director and others in the building were certified/recertified in basic life support and first aid.
- Interviews about EC activities were provided to reporters from *The Chronicle of Higher Education* and the *Anderson Independent Mail.* As well as written reports submitted to *AROHE Matters.*
- Efforts are underway to improve signage on the outside of the building to designate the Emeritus College at the location. These efforts are in conjunction with Regulatory Services and PSA which also are in the facility.

# 2018-19

## **Strategic Goal Achievements**

- 1. Increase visibility and recognition of the Emeritus College across the University and beyond:
  - Logo developed and deployed to all EC communications and documents.
  - Website updated and made interactive, moving the calendar of events and improving the directory of emeritus faculty.
  - *EC Happenings*: Weekly emails are transmitted to members regarding EC news and events.
  - *The Academy*: Newsletter designed highlighting EC events, news, etc. Several new designs are being considered for this upcoming year.
  - Due to transition of EC Director, meetings with Academic Deans and Department Chairs to promote the College's activities remains a work in progress. During the spring, the Dean of Libraries, the VP

for Information Technology, and three associate provosts were invited speakers.

- The 41% decrease in annual giving to the Emeritus College is a concern and an effort to promote giving for scholarships and general activities for the College was initiated with the April Giving Day. In addition, a meeting with VP Brian O'Rourke was initiated to address the philanthropic needs of the College. We thank the Provost and his office for his financial support of the Emeritus Day event in April.
- A summary of notable recognitions and accomplishments of emeritus faculty are included in this report.
- Efforts are underway to improve signage on the outside of the building to designate the Emeritus College at the location. These efforts are in conjunction with Regulatory Services and PSA which also are in the facility.
- Interviews with the director conducted by Anderson Independent Mail and The Chronicle for Higher Education. Two articles appeared in AROHE Matters (newsletter for the Association of Retirement Organizations in Higher Education) focusing on the CU Emeritus College's new director and programming initiatives.

#### 2. Increase involvement and engagement of all Emeriti Faculty in activities of the College:

- Communications with Academic Deans and Department Chairs remains a work in progress. All colleges were represented at the Annual Emeritus Day event at the Madren Center.
- Communication efforts to all EC members included updated printed newsletters and weekly emails on EC events.
- Plans for a survey of member interests is scheduled for the next academic year.
- Two Emeritus College committees made recommendations for the redesign of space for emeritus faculty. The computer room was downsized and more flexible space

and setting was developed to promote collaborative exchanges among EC faculty.

- Emeritus College awards were expanded to include a Research and Scholarship Award (presented to John Morse in October 2018) and a Community Service Award to be presented next academic year. These awards alternate rather than occurring annually.
- The I. Dwaine Eubanks Emeritus College Fellows program was approved and will be initiated next academic year.
- The Health and Safety of EC faculty is a primary concern and to reduce the risk of falls, new non-rolling chairs were added to the meeting room.
- Basic life support and first aid training was provided to more than 20 individuals in three departments housed in the building— Regulatory Services, Emeritus College, and Ansell. The building provides AED, respiratory masks, and other first aid components. The EC upgraded its first aid supplies as well.
- New emeritus faculty were invited to the Emeritus College, a first-time event, to encourage participation in the EC activities, meet EC faculty, and engage in a discussion about life after retirement.
- A Mac workstation was added to the computer workstations. These workstations total four (three Windows and one Mac) and are equipped as a computer lab with full access to color and black/white printing capabilities as well as university software.
- The College will now offer free notary services to its faculty.

#### 3. Serve Clemson University:

- President Clements, Provost Jones, and other University leaders attended the annual Emeritus Day recognition of new emeritus faculty and the luncheon following.
- Expansion of EC members' involvement on University Councils/Committees/Task Forces is a work in progress. EC is represented at

the Faculty Senate on a regular basis.

- Dr. Danny Weathers and Mr. Jerry Knighton have approached the College about developing a Faculty Advocacy Program.
- Student Alumni Council has approached the college about developing a student mentoring program. This initial meeting will be followed by coffee/lunch meeting in the Fall of 2019.
- Connecting emeriti faculty to their home departments remains a work in progress.
- EC faculty are actively involved in leading and supporting the CIS/CESP program for international students and faculty. Fall 2018: CESP 32 Students and CIS 2 students; Spring 2019: CESP 21 students and CIS 3 students. Total of 8 faculty participated in both programs for 2018-19. This program was recognized with a national AROHE award in October 2018.
- Two undergraduate student scholarships of \$1,000.00 each were presented this year to: Sophia Nance and Sarah Wetherell.
- Clemson faculty presented programs on the Social Media Listening Center, the Russian influence on the 2016 and 2018 elections, the Big Tent Technology Initiative and the library. We had music events highlighting student performers, as well as emeritus and current faculty musicians.
- EC faculty participated with HR in retirement briefings for Clemson faculty.
- EC faculty (**Thomas Hughes**) periodically provide classroom support as substitute teachers. University service by EC members included assisting in the Academic Success Center, Creative Inquiry classes, Study Abroad programs, and dissertation/thesis service.
- Vic Shelbourne served as co-chair and Provost Fellow of the Clemson University Commission on Sustainability.

#### 4. Serve the broader community:

• EC faculty continued to support numerous non-profit groups across the Clemson

community, including, but not limited to OLLI, Sertoma, the Free Clinic, the Clemson Community Foundation, and others.

# 5. Facilitate substantive, quality social and educational program of events for Emeriti Faculty:

- Major EC social events in 2018-19 included: Fall Picnic and Annual Meeting (220), Emeritus Day (270), and Holiday Social (195).
- During the spring of 2019, 29 educational events were held by the College with opportunities for emeritus faculty to have a no-host lunch with the presenters following (or during) the presentation; 408 faculty participated. A list of programs is included.

Some visitors (n=149) released banded birds back into the wild. In the following weeks, each releaser received a certificate from PRTM containing information about the life history of the species he/she released along with the band number and date of release. Seven releasers from previous vears received notices from PRTM that "their" bird had returned to the Station this year. Dr. Howard has volunteered at the Station each year since 1984.



# New and Noteworthy at Clemson University Emeritus College

A new year and new leadership provided an opportunity to both celebrate our tradition of excellence and to introduce new ideas that help us reach goals expressed in our Strategic Plan. Our Director, Dr. Debra Jackson, led the way in developing thematic programming. By providing a series of different events that are linked with the same broad topic of general interest, emeritus faculty can choose how they best would like to explore, learn from, and contribute to that topic. This type of coordinated programming also provides a way to spotlight some unique programs, talents, and interests of both the University and the Emeritus College. The first theme chosen was Social Media. A seminar given by the Director of Clemson's Social Media Listening Center was the kick-off event. We learned that the Center is a state-of-the art interdisciplinary research and teaching facility. It monitors, measures, and engages in social media conversations across the web. A second seminar later in the semester was given by two faculty researchers, one from Communications and one from Economics. Most of us had little idea that this collaborative research facility even existed, much less its importance to such diverse contexts as the 2016 U.S. presidential election and cyberbullying. An Orange-Bag Lunch, now called a Focus-Discussion lunch, gave us a chance to participate in a special project on Civil Dialogue that included the influence of social media on racial understanding. Several workshops on cyber security, including hands-on experiences in our well-equipped computer lab, helped bring individualized practical advice to our faculty.

The second theme chosen was Music. This theme was introduced with a lecture-recital in the auditorium of the Emeritus College. The Director of Artistic Initiatives for Clemson's Brooks Center for the Performing Arts, Dr. Eric Lapin, came and brought three students who performed, discussed historical background of their music, and gave demonstrations of their instruments. We enjoyed and learned about the trumpet and two different types of clarinets.

In conjunction with the Greater Clemson Music Festival, we were treated to an acoustic performance by the Carl Neil Trio, a combination of guitar, violin, and mandolin. There was opportunity to lunch together after this event, giving members more chance to talk with the performers. The next live performance at the College featured "Old Time" string tunes played by a fantastic trio (lead guitar, rhythm guitar, banjo) of current and emeritus faculty. The group played and answered questions from the engaged audience, with the discussion continuing over lunch. Later this summer we are looking forward to more musical events, including a private behind-the-scenes tour of the Brooks Center for the Performing Arts and a lecture-recital provocativelytitled the "Life, Death and Resurrection of a Musical Instrument." This presentation will be given by an Alumni Distinguished Professor Emeritus of Electrical Engineering Lew Fitch.

The third change was to repurpose existing space to enable a salon-type atmosphere

to develop. This suggestion came from a member of the College who had been contemplating that the College was missing was а space with comfortable а setting in which to have informal collaborative exchanges. These activities



are developed by the emeritus faculty and are as varied as forums for active interest groups to shared interest gatherings in arts, literature or science. The Director and Advisory Board agreed, the costs were manageable, and such a space quickly became a reality by redesigning our large computer lab. By keeping an adequate number of upgraded computer stations, this generously-sized room now serves both its original purposes and encourages new types of interactions. The salon atmosphere is enhanced by the ever-changing original art, all created by Emeritus College members. With a cofee nook, this truly is a space that belongs to the members and we are eagerly looking forward to seeing how our new salon is utilized.
